In Continuation of our earlier letters dated 03.12.2016 & 01.02.2017 regarding payment of balance of site deposit instalment and submission of documents for seniority approval, many of the site applicants have already paid the site installment and also submitted documents for seniority approval. But a few more are yet to pay the site instalment and they are expressing difficulties due to demonetization. We can understand their hardships. But at the same time, unless members help us with timely payment, project completion gets delayed. Members may please note as was informed earlier itself, the Initial deposit of Rs.250/- per Sq ft Collected was for Procurement of land Only. After receiving Approval from Govt. for change of land use, this Instalment is being called for further Development works. Since the last allotment made was at Rs. 500/- per Sq ft, the final allotment Cost for this Project is likely to be more than this. Layout works are progressing well and likely to be completed by Sep-2017 for which we are consistently working hard.

Considering the appeal and request of many members and all other aspects, the board at its meeting deliberated in detail and decided to **extend the date for payment up to 17.04.2017**. There shall not be any more extension and this shall be final deadline to make payment. **Please Note**. Default in payment before the due date will affect your seniority and your seniority may not be approved by Co-Op Department. **Please Note**.
